My most popular article, *Data Colonialism: Rethinking Big Data's Relation to the Contemporary Subject* (co-authored with Nick Couldry and published in *Television and New Media* in 2019) has been downloaded more than 43,000 times from the journal page, 24,000 times from the LSE page, and has about 1,425 citations according to Google Scholar.
